Although the finish is extremely durable, it can be **DAMAGED** by **ACIDIC CLEANERS** (i.e. cleaners designed specifically for vitreous china lavatories and water closets), **HARSH ABRASIVES** or **POLISH**. To clean, simply wipe the surface with a damp cloth and blot dry with a soft cloth.
