MODEL PGVFSBFSL-BRB-FVF

Suggested Specification

Model PGVFSBFSL-BRB-FVF is a non-refrigerated fountain and delivers ambient water. Shall include the VersaFiller Bottle Filler with mechanical activation; each fountain shall have a single vandal resistant push button to activate the manual flow of water for the cooler. Bottle Filler alcove and cabinet finish shall be stainless steel. Key VersaFiller components contain Freshield®, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew. Basin shall be designed to eliminate splashing and standing water. Vandal Resistant water saver bubbler to reduce waste water by 50% and operate between 20 and 100 PSI. One-piece vandal resistant metal bubbler keyed into place to prevent vandalism. Cabinet finish shall be brushed stainless steel. Cabinet shall have galvanized steel screens to prevent objects from being inserted into ventilation panel or underside of unit. Shall comply with ANSI 117.1 and ADA. Shall be listed by Underwriters Laboratories to US and Canadian standards. Shall comply with NSF/ANSI 61 and NSF/ANSI 372.
